

COMMISSIONERS' ORDINANCE NO. O-04-2025

AN ORDINANCE AMENDING CHAPTER 94.003 OF THE COVINGTON CODE OF ORDINANCES, TITLED "CITY PARKS AND RECREATION SYSTEM AVAILABLE TO THE PUBLIC", TO REVISE THE PARKS LIST TO INCLUDE ADDITIONAL PARKS.

WHEREAS, the Chapter 94.003 of the City of Covington Code of Ordinances currently sets forth the names of most, but not all, of the city's parks available for public use; and

WHEREAS, the City's Parks and Recreation department desires to update the online list of Covington parks available to the public.

NOW THEREFORE,

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF COVINGTON, KENTON COUNTY, KENTUCKY AS FOLLOWS:

Section 1

Chapter 94.003 of the Covington Code of Ordinances is hereby amended to read as follows:

CHAPTER 94: PARKS AND RECREATION AND PUBLIC PROPERTY

§ 94.003 CITY PARKS AND RECREATION SYSTEM AVAILABLE TO THE PUBLIC.

Upon the establishment of a city park, the park shall be added to the City Parks and Recreation System established by the City Board of Commissioners in this section. The City Parks and Recreation System sets forth the name, address, and park classification of each city park available to the public for use. If a city park is decommissioned by the City Board of Commissioners, the city park shall be removed from the City Parks and Recreation System. The current City Parks and Recreation System follows:

Section 2

If any section, clause, sentence, part, or provision of this chapter shall be held illegal, invalid, or unconstitutional by any court of competent jurisdiction, such decision of the court shall not affect, impair, or invalidate any of the remaining sections, clauses, sentences, parts or provisions of this chapter. 
