NOW THEREFORE,
BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF COVINGTON, KENTON COUNTY, KENTUCKY:

Section 1

Section 34.50 of the Covington Code of Ordinances is hereby amended as follows:

All positions created and all employees hired from August 26, 2005 to the effective date of this section and all positions created and employees hired following the effective date of this section, unless otherwise designated by union contract or applicable law.

(B) All employees who retained civil service status according to Section 34.40 shall continue to retain such status under applicable Kentucky law.

Section 2

Any ordinances or parts thereof in conflict herewith are to the extent of such conflict, hereby repealed.

Section 3

If any part of this is held to be invalid, the remaining parts shall remain in force.

Section 4

That this ordinance shall take effect and be in full force when passed, published, and recorded according to law.
