**Requirements:**

1. The dumpster must be illuminated with a warning light, light reflector or a reflective material visible to oncoming vehicles for a distance of not less than three hundred feet (300') between the hours of sunset and sunrise.
2. The dumpster must be equipped with a cover so that when not in use, the container will not accumulate significant amounts of water so as to cause leakage.
3. Liquid leachate must not leak from the container onto any street, sidewalk or public right-of-way.
4. The name of the company/dumpster owner responsible for placement and removal of the dumpster must be displayed on same as well as the dumpster tag.
5. At no time will a dumpster be placed onto any running lane of the roadway, restricting the flow of traffic.
6. The dumpster may be placed on or near the above-identified property in the location set forth herein. Only refuse from the above-identified property shall be placed in the dumpster.
7. The dumpster must be removed from the above-identified property no later than 90 days after the date of this permit. The dumpster may remain on the property after the 90 day period only if the holder of this permit has received an extension from the Code Enforcement Department. The holder of this permit must exhibit good cause as to why the extension is necessary before an extension will be granted.
8. The City of Covington may cause to have the dumpster removed from its location, at the permit holder's expense, if either (a) this dumpster permit or extension thereof is not in affect, or (b) the dumpster is at a location other than the above-identified property.

**PERMIT MUST BE ATTACHED TO THE CONTAINER AND VISIBLE FROM THE STREET**
